

ORDINANCE C-1-99

AN ORDINANCE TO ESTABLISH ADMISSION FEES FOR THE BIG SPLASH AT EVANS PARK

WHEREAS, the Big Splash at Evans Park will open in the summer of 1999; and

WHEREAS, the City Council and Administration have analyzed the business plan for the proposed facility;
and

WHEREAS, it is important to establish admission fees so that the business plan can be implemented; and

WHEREAS, On December 04, 1998 the Grove City Park Board passed a motion recommending the rates as established in Exhibit "A".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GROVE CITY,
STATE OF OHIO, THAT:

SECTION 1. This Council hereby sets the admission fee structure for the Big Splash at Evans Park as outlined in Exhibit "A", attached hereto and made a part hereof.

SECTION 2. Pursuant to our Agreement with Jackson Township, representatives of the City Administration, Council and the Jackson Township Trustees will meet after the completion of the operating season of the Big Splash at Evans Park to evaluate the operation, fee structure and fiscal position of this facility.


SECTION 3. This ordinance shall go into effect at the earliest opportunity allowed by law.




