

# ORDINANCE C-6-97

## AN ORDINANCE TO MAKE AMENDMENTS TO CHAPTER 161 OF THE CODIFIED ORDINANCES OF THE CITY OF GROVE CITY AND DECLARE AN EMERGENCY

WHEREAS, contained within the 1997 appropriation ordinance were employment wage increases; and

WHEREAS, in an effort to update employment provisions, titles and various other sections due to the enactment of new federal statues; and

WHEREAS, an emergency exists for the health, safety and welfare of the community.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GROVE CITY, STATE OF OHIO, THAT:


