

ORDINANCE C-34-93

AN ORDINANCE TO AMEND SECTION 1135 OF THE CODIFIED ORDINANCE ENTITLED ZONING DISTRICTS AND REGULATIONS

WHEREAS, for better control by the City to promote the safety and welfare of the City of Grove City, of the bartering or trading of weapons and/or explosives, as defined in Section 2923.11 of the Ohio Revised Code, the sellers or lessors shall obtain a special use permit from the City.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GROVE CITY, STATE OF OHIO, THAT:

SECTION 1. Section 1135.09(12) under Special Use Permits of the Codified Ordinance which reads:

A. 24. Sale or Rental of WEAPONS AND/OR EXPLOSIVES as defined in Section 2923.11 of the Ohio Revised Code and as stipulated in Section 1135.09F of the Codified Ordinances.

IS HEREBY AMENDED TO READ:

A. 24. Sale, Rental, *Barter or Trade* of WEAPONS AND/OR EXPLOSIVES as defined in Section 2923.11 of the Ohio Revised Code and as stipulated in Section 1135.09F of the Codified Ordinances.

SECTION 2. Section 1135.09F titled Permitted Uses; Standard Industrial Classification Manual; Adoption By Reference which reads:

- F. No permit for the Sale or Rental of Weapons and/or Explosives shall be granted unless:
1. Must be a minimum of 500 feet from a residential district;
 2. Must a minimum of 50 feet from a business or structure that is used to store, sell or distribute any flammable material as defined in Section F 201 of the BOCA Fire Prevention Code;
 3. Must be located in a building with no other use;
 4. Building must be separated from any other structure by a distance of no less than 30 feet and no closer to any abutting lot than six feet.

IS HEREBY AMENDED TO READ:

- F. No permit for the Sale, Rental, *Bartering or Trading* of Weapons and/or Explosives shall be granted unless:

1. Must be a minimum of 500 feet from a residential district;
2. Must a minimum of 50 feet from a business or structure that is used to store, sell or distribute any flammable material as defined in Section F 201 of the BOCA Fire Prevention Code;
3. Must be located in a building with no other use;
4. Building must be separated from any other structure by a distance of no less than 30 feet and no closer to any abutting lot than six feet.

SECTION 3. This ordinance shall take effect at the earliest opportunity allowed by law.
