

ORDINANCE NO. 11-56

ACCEPTING THE DEDICATION OF THE THREE-FOOT STRIP
ON THE EAST SIDE OF THE FIRST TWELVE FOOT ALLEY
EAST OF BROADWAY AND PARALLEL WITH BROADWAY RUN-
NING FROM PARK STREET TO CIVIC DRIVE

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GROVE
CITY, STATE OF OHIO:

SECTION 1: THAT THE DEED FROM MINNIE M. PETERS, ERNEST G.
GOOD, AND DOROTHY L. GOOD, OF A THREE-FOOT
STRIP OF LAND HEREINAFTER DESCRIBED, BE AND
THE SAME IS APPROVED AND ACCEPTED, AND THAT
THE DEDICATION FOR PUBLIC USE FOR SAID AREA
IS HEREBY ACCEPTED AND CONFIRMED, SAID AREA
BEING DESCRIBED AS FOLLOWS:

SITUATED IN THE COUNTY OF FRANKLIN, IN THE
STATE OF OHIO, AND IN THE VILLAGE OF GROVE
CITY: BEING THREE FEET OFF THE ENTIRE WEST
SIDE OF A TRACT OF LAND CONVEYED BY HENRY W.
BAUMGARTNER TO MINNIE M. PETERS, ET AL, BY
DEED OF RECORD IN DEED BOOK 1877, PAGE 362,
RECORDER'S OFFICE, FRANKLIN COUNTY, OHIO,
AND BEING MORE PARTICULARLY DESCRIBED AS
FOLLOWS: BEGINNING AT A POINT AT THE SOUTH-
WEST CORNER OF SAID TRACT; THENCE NORTHERLY
ALONG THE WEST LINE OF SAID TRACT, ADJACENT
TO A 12 FOOT ALLEY, 98.3 FEET TO AN IRON PIN
IN THE NORTHEAST CORNER OF SAID TRACT; THENCE
EASTERLY 3.0 FEET TO A POINT-; THENCE SOUTH-
ERLY AND PARALLEL TO THE WEST LINE OF SAID
TRACT 98.3 FEET TO A POINT IN THE SOUTH LINE
OF SAID TRACT; THENCE WESTERLY ALONG THE
SOUTH LINE OF SAID TRACT 3.0 FEET TO THE
PLACE OF BEGINNING.

SECTION 2: THAT THIS ORDINANCE SHALL TAKE EFFECT AND BE ENFORC-
ED AFTER THE EARLIEST PERIOD ALLOWED BY LAW.
