

# ORDINANCE C-12-10

AN ORDINANCE TO AUTHORIZE THE CITY ADMINISTRATOR TO ENTER INTO A COOPERATIVE AGREEMENT WITH FRANKLIN COUNTY AND JACKSON TOWNSHIP FOR WHITE ROAD RECONSTRUCTION, PHASE 2 AND TO APPROPRIATE \$375,000.00 FROM THE GENERAL FUND FOR SAME

---

WHEREAS, the City has been working in cooperation with Jackson Township, Franklin County and the Ohio Public Works Commission in making Phase II improvements to White Road; and

WHEREAS, Phase II Improvements will result in the reconstruction and widening of 2,850 feet of White Road from +550' east of McDowell Road to the west side of the intersection of Grand Crossing Blvd.; and

WHEREAS, a Cooperative Agreement between the City, Franklin County and Jackson Township is necessary to provide for the efficient and coordinated development of the Improvements; and

WHEREAS, engineering and related services are necessary in order to complete work under the Ohio Public Works Commission Grant Agreement.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GROVE CITY, STATE OF OHIO, THAT:

SECTION 1. The City Administrator is hereby authorized to enter into a Cooperative Agreement with Franklin County and Jackson Township for the White Road Reconstruction, Phase 2 improvements.

SECTION 2. There is hereby appropriate \$375,000.00 from the unappropriated monies of the General Fund to be transferred into the Capital Improvement Program and appropriated to account number 305-3078-3600-780 form the Current Expense of engineering services for the development of surveying, engineering plans, storm water management and water quality plan and bidding.

SECTION 3. This ordinance appropriates for current expenses and shall therefore go into immediate effect.

**COOPERATIVE AGREEMENT  
BETWEEN  
FRANKLIN COUNTY, JACKSON TOWNSHIP,  
AND  
THE CITY OF GROVE CITY**

WHEREAS, the project known hereafter as **WHITE ROAD RECONSTRUCTION, PHASE 2** has utility to the general public of Franklin County, Jackson Township, as well as to the citizens of the City of Grove City; is an important roadway on the county and municipal highway system for through traffic; and the public interest demands its rehabilitation; and

WHEREAS, Franklin County through the County Engineer, Jackson Township through its Administrator, and the City of Grove City through its Administrator, do hereby mutually agree to cooperate in the planning, design and construction of the project; and

WHEREAS, it has been determined that the general scope of the project will include the reconstruction and widening of White Road from the terminus of the Phase 1 improvements at McDowell Road to just west of the Buckeye Parkway intersection, along with the ancillary work required for the improvement as defined in the Round 24 Ohio Public Works Commission (OPWC) Application; and

NOW, THEREFORE, the Parties agree to the following responsibilities:

**FRANKLIN COUNTY** will:

1. Declare the improvement necessary.
2. Acquire all necessary right-of-way, easements and work agreements necessary for the improvements within County jurisdiction.
3. Provide financial support for the improvement not to exceed 33.3% of the local match (\$809,547.00) toward the total project cost.
4. Review and approve the right-of-way and construction plans for the project.
5. Oversee and provide bid procurement efforts including bid documents, receive bids, and award a construction contract for this improvement.
6. Coordinate construction phase administration and inspection services for the project.
7. Operate and maintain the completed portion of the project within the County jurisdiction.

**JACKSON TOWNSHIP** will:

1. Declare the improvements necessary.
2. Provide financial support for the improvement not to exceed 33.3% of the local match (\$809,547.00) toward the total project cost.
3. Review and approve the right-of-way and construction plans for the project.
4. Submit and enter into agreement with the Ohio Public Works Commission regarding the funding of the said improvements under the Round 24 Application for funding assistance.

**The CITY OF GROVE CITY will:**

1. Declare the improvements necessary.
2. Coordinate with Franklin County and Jackson Township in all public improvements for the project.
3. Provide professional services through the City's consulting engineering firm to provide right-of-way and detailed construction plans for the project and identify this contribution as financial support towards the improvement.
4. Provide interim and final right-of-way and construction plans to Franklin County and Jackson Township for review and approval.
5. Coordinate with Franklin County and Jackson Township on utility related issues and relocations for the project and lead effort with utilities.
6. Provide financial support for the improvement not to exceed 33.3% of the local match (\$809,547.00) toward the total project cost.
7. Provide all necessary documentation for right-of-way, easements and work agreements necessary for the improvements and coordinate with County and Township on acquisition efforts.
8. Operate and maintain the completed portion of the project with the Grove City jurisdiction.
9. Provide Franklin County with a maintenance agreement with respect to street lighting, bike path, and sidewalk improvements within the County's jurisdiction.
