

ORDINANCE C-14-04

AN ORDINANCE TO DIRECT THE CERTIFICATION TO THE COUNTY AUDITOR OF THE EXPENSE FOR CUTTING WEEDS ON PRIVATE PROPERTY

WHEREAS, by Section 543.02 of the Codified Ordinances of the City of Grove City, adopted April 18, 1988 by Ordinance No. C-92-00, Council directed the giving of notice to certain owners and persons having charge of lands, of the growth of noxious weeds and other vegetation of rank growth thereon and directing that such be cut and destroyed; and


WHEREAS, such notice was duly given, and thereafter the City caused such growth to be cut and destroyed in instances where the above mentioned notice and order had not been complied with; and

WHEREAS, expenses were incurred by the City in cutting and destroying said growth, in the amounts set forth in Exhibit "A" attached hereto and made a part hereof, which exhibit contains the names of the non-complying owners, the identity of their lands, and the amounts of such expenses.


NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GROVE CITY, STATE OF OHIO, THAT

SECTION 1. The Clerk of Council is ordered to certify a copy of this ordinance to the Auditor of Franklin County, Ohio, and said Auditor is directed to enter said expenses on the tax duplicate of this County, as provided by Section 731.54 of the Ohio Revised Code.

SECTION 2. This ordinance shall go into effect at the earliest opportunity allowed by law.






