

ACCEPTING APPLICATION FOR ANNEXATION OF
TERRITORY

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GROVE CITY,
STATE OF OHIO:

SECTION I: THAT THE APPLICATION OF RALPH RUSH THOMAS, JR., AND
OTHERS FOR THE ANNEXATION OF THE FOLLOWING DESCRIB-
ED TERRITORY IN THE COUNTY OF FRANKLIN, AND ADJACENT TO THE
VILLAGE OF GROVE CITY, TO-WIT:

BEGINNING AT AN ANGLE POINT IN THE EXISTING CORPORATION LINE
OF THE VILLAGE OF GROVE CITY AND IN THE SOUTHERLY RIGHT OF
WAY LINE OF STRINGTOWN ROAD (60 FEET IN WIDTH) AT ITS INTER-
SECTION WITH A SOUTHERLY EXTENSION OF THE EASTERLY LINE OF
J. C. EVANS SUBDIVISION AS THE SAME IS RECORDED IN PLAT BOOK
26, PAGE 23-A, FRANKLIN COUNTY RECORDER'S OFFICE; THENCE
NORTHERLY WITH THE EXISTING CORPORATION LINE OF THE VILLAGE
OF GROVE CITY AND WITH THE EASTERLY LINE OF SAID SUBDIVISION
AND ITS SOUTHERLY EXTENSION, A DISTANCE OF 379 FEET, MORE OR
LESS, TO THE CENTER LINE OF LA ROSA DRIVE (50 FEET IN WIDTH)
OF SAID SUBDIVISION; THENCE EASTERLY, PARALLEL TO STRINGTOWN
ROAD, WITH THE NORTHERLY LINES OF THE GROVE CITY METHODIST
CHURCH 3.565 AND 1.242 ACRE TRACTS AND THE OPAL M., AND RALPH
RUSH THOMAS JR., 1.6024 ACRE TRACT, A DISTANCE OF 800 FEET,
MORE OR LESS, TO A POINT AT THE NORTHEASTERLY CORNER OF THE
OPAL M., AND RALPH RUSH THOMAS, JR., 1.6024 ACRE TRACT; THENCE
SOUTHERLY, WITH THE EASTERLY LINE OF SAID OPAL M., AND RALPH
RUSH THOMAS, JR., 1.6024 ACRE TRACT, AND WITH SAID EASTERLY
LINE EXTENDED SOUTHERLY, AND PARALLEL TO THE SAID EASTERLY
LINE OF SAID SUBDIVISION, A DISTANCE OF 379 FEET, MORE OR
LESS, TO A POINT IN THE SOUTHERLY RIGHT OF WAY LINE OF
STRINGTOWN ROAD (60 FEET IN WIDTH) AND IN AN EXISTING NORTH-
ERLY CORPORATION LINE OF THE VILLAGE OF GROVE CITY; THENCE
WESTERLY, WITH SAID SOUTHERLY RIGHT OF WAY LINE OF STRINGTOWN
ROAD AND WITH THE EXISTING CORPORATION LINE OF THE VILLAGE OF
GROVE CITY, A DISTANCE OF 800 FEET, MORE OR LESS, TO THE PLACE
OF BEGINNING, CONTAINING 6.96 ACRES OF LAND, MORE OR LESS.

AN ACCURATE MAP OF WHICH TERRITORY, TOGETHER WITH THE PETITION
FOR ITS ANNEXATION AND OTHER PAPERS RELATING THERETO, AND A
CERTIFIED TRANSCRIPT OF THE PROCEEDINGS OF THE COUNTY COMMIS-
SIONERS IN RELATION THERETO ARE ON FILE WITH THE CLERK OF SAID
VILLAGE, BE AND THE SAME IS HEREBY ACCEPTED.

SECTION II: THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE
FROM AND AFTER THE EARLIEST PERIOD ALLOWED BY LAW.
