

ORDINANCE NO. C-62-72

AN ORDINANCE TO AMEND CHAPTER 31 ENTITLED " CLASSIFICATION AND COMPENSATION PLAN" OF THE 1966 GROVE CITY CODE OF ORDINANCES; TO RESCIND IN SECTION 31.04 (B) MAINTENANCE WORKER, NUMBER OF EMPLOYEES 4, AND WWT PLANT OPERATOR,NUMBER OF EMPLOYEES 2, AND SUBSTITUTE THEREFOR: MAINTENANCE WORKER, NUMBER OF EMPLOYEES 5, AND WWT OPERATOR,NUMBER OF EMPLOYEES 3; AND TO INCLUDE THE POSITION OF CLERK-TYPIST AND TO DECLARE AN EMERGENCY.

WHEREAS , with the continuous growth of Grove City it is necessary to increase our manpower in the Service Departments, and

WHEREAS, personnel in the Divison of Service and Division of Streets has not been increased for 11 years, and

WHEREAS, an emergency exists in the safety, health and welfare of the citizens of Grove City that these departments have increased personnel as soon as possible, and

WHEREAS, a clerk-typist has been hired to fill the position #8 under Section 31.04 (a).




SECTION 1. Section 31.04 (B) entitled "Number of employees in various departments is rescinded and the following substituted:


