

ORDINANCE NO. C-64-77

AN ORDINANCE APPROVING THE EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF THE CITY OF GROVE CITY, OHIO.

WHEREAS, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of the City;



SECTION 3. This ordinance shall take effect and be in force from and after the earliest period allowed by law.


