

ORDINANCE

C-66-60

An Ordinance to amend Ordinance #C-36-60 and Ordinance #C-42-60 Providing for Annual Appropriations

WHEREAS, the appropriation ordinance and amendments thereto, appropriated monies in excess and in deficiency of certain accounts, and

WHEREAS, the total of such appropriations is sufficient, and

WHEREAS, it is necessary to make adjustments in certain sub-accounts but not to appropriate additional funds for any fund, and

WHEREAS, such adjusted appropriations are immediately necessary to maintain the health, safety and morals of the City of Grove City

NOW, THEREFORE, Be It Ordained by the Council of the City of Grove City that
