

ORDINANCE NO. C-90-77

AN ORDINANCE TO AUTHORIZE THE ADMINISTRATIVE ASSISTANT TO ENTER INTO A CONTRACT WITH THE CITY OF COLUMBUS, DEPARTMENT OF SAFETY, FOR SERVICES OF THE COLUMBUS POLICE CRIME LABORATORY

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GROVE CITY, STATE OF OHIO, THAT

SECTION 1. The Administrative Assistant is hereby authorized and directed to enter into a contract for services of the Columbus Police Crime Laboratory so that the Grove City Police Department may have available the expertise and routine services of the Columbus Police Crime Laboratory and its Technicians.

SECTION 2. Said contract is marked exhibit "A" and attached hereto and made a part of this ordinance.

SECTION 3. There is hereby appropriated the sum of \$5,000.00 from the unappropriated monies of the General Fund to pay for these services through the year 1978.

SECTION 4. The terms of this contract shall be retroactive to November 1, 1977.


SECTION 5. Said contract shall be in full force until cancelled by either party, pursuant to the terms of the contract.

SECTION 6. This ordinance shall take effect at the earliest opportunity allowed by law.







EXHIBIT "A"

CONTRACT FOR SERVICES OF  
COLUMBUS POLICE CRIME LAB

This contract is made and entered into at Columbus, Ohio this \_\_\_\_\_ day of \_\_\_\_\_, 1977, pursuant to Ordinance No. 1946-76, adopted by the City Council of the City of Columbus, Ohio at its November 22, 1976 meeting, by the City of Columbus, acting through the Division of Police, Department of Public Safety, hereinafter referred to as the "City,"

and

IT IS HEREBY AGREED among and between the said City and the Contractor that the said City shall provide the services of the Columbus Crime Lab as set forth below. Moreover, the said Contractor agrees to pay to the City the said amounts designated below for the specified services. The City shall invoice the Contractor for the services performed. The Contractor shall make payment to the City of Columbus, in care of the Business Office, Columbus Division of Police, Columbus, Ohio, within thirty days upon receipt of the said invoice.

IT IS ALSO AGREED among and between the said parties that the collection, processing, preservation, and identifying of the items submitted to the Columbus Crime Lab for the above services shall be controlled by the directives issued by the supervisor of the Columbus Crime Lab.

IT IS FURTHER AGREED between and among the parties to this contract that this Agreement shall be terminated upon sixty (60) days written notification by either party. The said Contractor also agrees that pursuant to the mandates of Section 3909.01, Columbus City Code, 1959, it is obligated to comply with the provisions of Attachment I to this contract.
