

RESOLUTION NO. CR-4-90

A RESOLUTION TO RESCIND RESOLUTION NO. CR-85-89,
A RESOLUTION OF INTENT TO APPROPRIATE AN EASEMENT
INTEREST IN CERTAIN LANDS FOR THE CONSTRUCTION
OF A SANITARY SEWER FOR THE CITY OF GROVE CITY

WHEREAS, on November 6, 1989, Resolution No. CR-85-89 was adopted by this Council for the purpose of stating the intent of the City to appropriate certain properties for easements for the construction of the Grant Run Trunk Sewer; and

WHEREAS, the provisions of the resolution of intent were not completed in a timely manner and the intent must be restated;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GROVE CITY, STATE OF OHIO, THAT

SECTION 1. Resolution No. CR-85-89 adopted by the Council of the City of Grove City on November 6, 1989 is hereby rescinded and the provisions of the resolution are null and void.

SECTION 2. This resolution shall take effect at the earliest opportunity allowed by law.

Robert and Beverly Sexten
