

RESOLUTION NO. CR-49-92

A RESOLUTION TO SET FORTH, AS REQUIRED BY SECTION 709.031 OF THE OHIO REVISED CODE, THE MUNICIPAL SERVICES THAT CAN BE FURNISHED TO A 280.415 ACRE TRACT ON THE EAST AND WEST SIDE OF HOOVER ROAD, NORTH OF STATE ROUTE 665 AND NORTHWEST OF STATE ROUTE 665 IN JACKSON TOWNSHIP UPON ITS ANNEXATION TO THE CITY OF GROVE CITY

WHEREAS, a petition to annex 280.415 acres on the east and west side of Hoover Road, North side of State Route 665 and northwest of State Route 665, in Jackson Township to the City of Grove City and signed by Jane A. Stark, Martin & Virginia Bell, Virginia Lintz, Donald Rings, Jack & Ruth Strader, Elanor Monaghas, Carl Patzer, Viola Smith, John Hampson, Donald Miller, Mark List, and Edwin White , was filed with the Board of County Commissioners of Franklin County, Ohio; and

WHEREAS, a hearing on this petition is scheduled before the Board of County Commissioners of Franklin County on December 02, 1992; and

WHEREAS, Section 709.031 of the Ohio Revised Code requires that the legislative authority of the municipality to which the annexation is proposed adopt a statement indicating what services, if any, the municipal corporation will provide to the territory proposed for annexation upon its annexation.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GROVE CITY, STATE OF OHIO, THAT:

SECTION 1. Upon its annexation to the City of Grove City, the 280.415 acre tract on the east and west side of Hoover Road, North side of State Route 665 and northwest of State Route 665 proposed for annexation by above mentioned property owners, will receive the following municipal services from the City of Grove City:

- Fire: Jackson Township will continue to provide Fire protection. The response time is three minutes.
- Police: Subject property is within the overall area now covered by the Grove City police cruisers. The response time is under five minutes.
- Water: There is an existing 12" water line located on Hoover Road and 8" line on State Route 665. Water for subject tract will be available when this water line is extended at the property owner's expense.
- Sanitary Sewer: This tract is within the overall service area included in the contract between the City of Grove City and the City of Columbus, however, no sewer lines are presently available to service this tract.
- Garbage & Refuse Collection: Subject property is now serviced by and will continue to be serviced by the same private collection service that now serves the incorporated area of the City.

SECTION 2. This resolution shall take effect at the earliest opportunity allowed by law.
