

RESOLUTION NO. CR-28-89

A RESOLUTION SPECIFYING THE GROVE CITY AREA CONVENTION AND VISITORS' BUREAU AS THE CONVENTION AND VISITORS BUREAU WHICH WILL RECEIVE FIFTY PERCENT OF THE REVENUE FROM THE TAX LEVIED PURSUANT TO SECTION 192.021 OF THE CODIFIED ORDINANCES OF THE CITY OF GROVE CITY ON TRANSACTIONS BY WHICH LODGING BY A HOTEL IS OR IS TO BE FURNISHED TO TRANSIENT GUESTS.

WHEREAS, the Council of The City of Grove City, State of Ohio, is a legislative authority of a municipal corporation as contemplated in Section 5739.024(B), Ohio Revised Code; and

WHEREAS, Section 5739.024(B), Ohio Revised Code, provides that the legislative authority of a municipal corporation that is not wholly or partly located in a county that has in effect a resolution levying an excise tax pursuant to Section 5739.024(A), Ohio Revised Code, may by ordinance levy an excise tax not to exceed three percent on transactions by which lodging by a hotel is or is to be furnished to transient guests; and

WHEREAS, The City of Grove City, State of Ohio, is not wholly or partly located in a county that has in effect a resolution levying an excise tax pursuant to Section 5739.024(A), Ohio Revised Code; and

WHEREAS, The City of Grove City levied a tax pursuant to Section 5739.024(B), Ohio Revised Code, and said tax was in addition to any tax imposed on the same transaction by The City of Grove City as enacted pursuant to Ordinance C41-76 (Passed 5-17-76.) and codified in Chapter 192 of the Codified Ordinances of The City of Grove City;

WHEREAS, Section 192.021 of the Codified Ordinances of The City of Grove City was amended pursuant to Ordinance C-123-88 (Passed 1-16-89) and said Section 192.021 provides that fifty percent of the revenue from the tax levied pursuant to said Section 192.021 shall be deposited into a separate fund, which shall be spent solely to make contributions to convention and visitors' bureaus operating in the county in which The City of Grove City is located;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GROVE CITY, STATE OF OHIO, THAT

Section 1. Fifty percent of the revenue generated from the tax levied pursuant to Section 192.021 of the Codified Ordinances of The City of Grove City, and until this Council otherwise provides, shall be deposited into a separate fund and shall be spent solely to make contributions to The Grove City Area Convention and Visitors' Bureau.



Section 3. This resolution shall take effect at the earliest opportunity allowed by law.


