RESOLUTION NO. 7-18

RELATIVE TO DECLARING THE NECESSITY FOR THE IMPROVEMENT OF COLUMBUS STREET IN THE VILLAGE OF GROVE CITY, OHIO, BY THE EXTENSION OF THE WATER LINES OF SAID COLUMBUS STREET, FROM SECURITY DRIVE, TO THE EAST CORPORATION LINE OF THE VILLAGE OF GROVE CITY, OHIO.

BE IT RESOLVED by the Village of Grove City, Ohio, three-fourths of all members elected thereto concurring:

Section 1. That it is necessary to improve Columbus Street, from Security Drive, to the east corporation line of the Village of Grove City in the following manner: namely, by construction of an eight (8) inch water line with all necessary castings, valves and hydrants.

Section 2. That said street improvements shall be as shown in the engineer's plans and profiles which are made a part hereof.

Section 3. That the plans, specifications, estimates and profiles of the proposed improvement heretofore prepared by the engineer, be and the same are hereby approved.

Section 4. That the whole cost of said improvement, less one-fiftieth thereof, shall be assessed in proportion to the benefits which may result from the improvement upon the following described lots and lands: "improvement of Columbus Street, from Security Drive, to the east corporation line of Grove City," which said lots and lands are hereby determined to be specifically benefited by said improvement; and the cost of said improvement shall include the expense of the preliminary and other surveys and of printing and publishing the notices, resolutions and ordinances required, and the serving of said notices, the cost of construction together with interest on notes and bonds issued in anticipation of the collection of deferred assessments, and all other necessary expenditures.

Section 5. That the assessments so to be levied shall be paid in ten (10) annual installments, with interest on deferred payments at the same rate as shall be borne by the bonds to be issued in anticipation of the collection thereof; provided, that the owner of any property assessed may, at his option, pay such assessment in cash within thirty (30) days after the passage of the assessing ordinance.

Section 6. That bonds of the Village of Grove City shall be issued in anticipation of the collection of assessments by installments and in an amount equal thereto, and notes of said Village of Grove City shall be issued in anticipation of the issue of such bonds.

Section 7. That the remainder of the entire cost of said improvement, not specially assessed, including the cost of intersections, together with the cost of any real estate or interest therein, purchased or appropriated, and the costs and expenses of any appropriation proceeding therefor, and the damages awarded any owner of adjoining lands and interest thereon, and the costs and expenses of any such award, shall be paid out of the Columbus Street improvement fund.

Section 8. This resolution shall take effect and be in force from and after the earliest period allowed by law.
