

ORDINANCE C-82-09

AN ORDINANCE TO DEDICATE BASEBALL FIELD #6 AT WINDSOR PARK AS THE ERNIE PLANK FIELD OF DREAMS AND TO APPROPRIATE \$3,200.00 FROM THE PARKS DONATION FUND FOR THE CURRENT EXPENSE OF A SCOREBOARD

WHEREAS, the City of Grove City is currently improving park and field conditions at Windsor Park; and

WHEREAS, the City of Grove City would like to honor Mr. Ernie Plank for his distinguished efforts to help start little league baseball in Grove City by dedicating Field # 6 at Windsor Park as the Ernie Plank Field of Dreams; and

WHEREAS, Ernie Plank's friends and associates have collected \$3,200.00 to fund a scoreboard for Field # 6 that will have dedication panels that read "Ernie Plank Field of Dreams"; and

WHEREAS, the following individuals and business have donated money for the funding of the scoreboard: Grove City High School Class of 1954, Jack & Carol McClure, James & Joan O'Conner, Don Osborn, Berkley & Joanne Roach, Dave & Nancy Feyh, Richard Schall, Ronald & Nancy Long, John Gutheil, Dr. John L. NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GROVE CITY, STATE OF OHIO, THAT:

SECTION 1. This Council does hereby dedicate baseball Field # 6 at Windsor Park as the "Ernie Plank Field of Dreams".

SECTION 2. There is hereby appropriated \$3,200.00 from the unappropriated monies of the Parks Donation Fund to be transferred into the Recreation Development Fund and appropriated to account #306-3000-3200-720-00046122-010, for the current expense of a Scoreboard.

SECTION 3. This ordinance appropriates for current expenses and shall therefore go into immediate effect.
